### Meditation

**“Finally, be strong in the Lord and in his mighty  
power. Put on the full armor of God, so that you can take  
your stand against the devil’s schemes.”  
Ephesians 6:10,11**

**PRAYER THOUGHT:** How do you put on the full armor of God? It isn’t as difficult as you might think. All the pieces of the armor are found in a relationship with Jesus. Paul said it like this: “Put on the Lord Jesus Christ” (Romans 13:14). When you give yourself to Jesus and “put on” His righteousness, you are clothed in the whole armor of God. Do you sometimes feel weak? Do you find yourself giving in to temptation when you really want to overcome? Are you ever discouraged? We all face these moments. But clothed in the full armor of God, the weakest of His children is more than a match for Satan.
